## Indiana Commercial Feed Manufacturers with Interstate Exclusion

*Effective July 1, 2025*

The following parties qualify under 355 IAC 6-1-12 of the Indiana Commercial Feed Law as parties furnishing substantial quantities of feed or feed ingredients at wholesale to distributors in other states. All feed or feed ingredients sold to these companies must be reported on page 4 and the exemption claimed on page 3 of the quarterly tonnage report. The parties listed below are then responsible for reporting ALL Indiana tonnage and paying the inspection fee on all Indiana sales.
