- Pesticide Disposal
- Open to anyone
 - Most participants are Farmers and Pesticide Businesses
- Allows for "no questions asked" disposal of suspended, canceled, banned, unusable, opened, unopened or just unwanted pesticides.
- If it is a pesticide, we will accept it for disposal.
- Locations change each year.
- 2nd and 3rd week of August

2023 Program Recap

- For the 4th consecutive year, OISC Clean Sweep has collected more banned, outdated, and unusable pesticides than the previous year.
- **77,130 lbs** of pesticides collected from **162** participants for disposal.
 - Total Cost of Disposal
 - \$176,890.38
- Recent trend of farm clean-up continues (Hardship Calls)
 - assisted three non-operational family farms and one non-operational ag dealer with property clean-up
 - largely outdated & cancelled products...14,000 pounds of pesticide waste
 - no longer a risk of contamination to the environment.

Funding


- Funding
 - EPA Funds \$70,000.00
 - Asking for as much as we can get for the 2024 program (100K)
 - Disposal cost have increased significantly
 - Disposal prices went up over \$1 a pound in the last 5 years.
 - OISC covers the remaining bill.
- Total Cost Breakdown
 - \$176,890.38
 - \$ 70,000.00 (EPA Funds)
 - \$ 36,812.00 (Overage Charges)
 - \$ 70,078.00 (OISC Share)


Increase in Overage Charge

- Free of charge up to 250 pounds per participant.
 - Prior to 2024, anything over 250 pounds was invoiced at \$2.00 per pound
 - Due to increase in overall cost of the program.
 - New for 2024, anything over 250 pounds will be invoiced at **\$3.00** per pound.






Our Rotary Kiln Incineration Process




