
### **Overview**

- Pesticide Disposal
- Open to anyone
  - Most participants are Farmers and Pesticide Businesses
- Allows for no questions asked disposal of suspended, canceled, banned, unusable, opened, unopened or just unwanted pesticides.
- If it is a pesticide, we will accept it for disposal.
- Locations change each year.
- 2<sup>nd</sup> and 3<sup>rd</sup> week of August

  - 33,161 pounds of waste pesticide
- Participants

  - Total Collected
    - ▶ 37,558 pounds of waste pesticide
  - Participants
    - > 231

#### 2021

- Total Collected
  - 59,211 pounds of waste pesticide
- Participants
  - ▶ 189
- 2022
  - Total Collected
    - 60,728 pounds of waste pesticide
  - Participants
    - ▶ 140

### **Increase in Collected Amounts**

- In speaking with participants during this year's program, the increase in demand can be attributed to several factors.
  - The next generation of farmers are taking over the family farm operations and no longer want the liability of having old, unknown, and or outdated pesticides on their farms.
  - Nonoperational farms are being sold. Farmers who buy these nonoperational farms are in turn inheriting the old, unknown, and or outdated pesticides that were stored in the outbuildings of these farms.
    - Family members inheriting nonoperational family farms.
  - Ag dealers being bought by other Ag Dealers and disposing of old and or outdated stock.

# Funding

#### Funding

- **EPA Grant** \$50,000.00
  - Will be asking for \$100k for the 2023 program
  - Disposal cost have increased significantly
    - > Disposal prices went up 20 to 40 cents a pound over previous year.
- Participant funding dependent on pounds submitted (250lbs free)
- OISC covers the remaining bill, if any.
- Disposal Contractor
  - Cost is price per pound
    - Heritage Environmental Fire
      - Unable to process waste
    - Rebid program
    - Awarded to MXI Environmental
      - > 55 cents more a pound to dispose


# Funding

- Total cost of program
  - ▶ \$118,419.60
    - Minus EPA funds, checks, and invoices
    - ▶ Total cost to OISC: \$57,635.60
- Difference in disposal contractor price
  - ▶ \$33,400.00
- Most weight collected since 2017 (Semi of Mini-bulks)




