I would like the following entered into the record of the Public Hearing scheduled for January 3, 2023 regarding LSA Document #22-329.

- 1. We believe the inclusion of the use of telephone text message to deliver post-treatment customer notification is a much needed change, reflects the use of technology in our industry, and also reduces the use of sometimes excessive paper. In the original, language, you included "within seven (7) days" as a timeframe for delivery. The new proposal omits this and I believe it should be reinserted as it does establish a timeline for such notifications to be transmitted.
- 2. "Harm vs Adverse Effect" We have had this discussion several times and my comment here is that using the term "adverse effect" instead of the term "harm", is going to cause a great deal of confusion as it is interpreted by different people in different ways as the definitions of these terms seem very different.

The term to cause harm is defined as causing physical or mental damage or injury, or causing someone to be hurt, broken, or made less valuable. Creating an adverse effect to a non-target site, seems to be taking a broad paint brush to this issue that may require more specifics.

Sorry that I could not be at the hearing but look forward to seeing you at the February PRB meeting.
