Registered Technician(RT) eligibility changes discussed. No supervision requirements for GUP use by RT's discussed. Questions asked about how RT video training is tracked. Sarah Caffery provided background to IPRB's dicamba decisions. Bill Johnson asked the question to the board "Should VRAs be required for applications of Dicamba to control winter annuals?" The question is asked because the mature soybeans are being harvested or near harvest and the volatility of dicamba to soybeans is less of a concern.
