IV. Type of Credentials Requested "Which box(es) do I check in Section II?"

- a) **Fertilizer Business License:** Required of any firm that applies or offers to apply fertilizer material (commercial fertilizer or manure) for hire. Must also check Section II (c) and include fee for at least one certified fertilizer applicator for hire working at this location.
- b) **Fertilizer Material Distributor:** Required of any firm that sells or offers to sell or distribute fertilizer material (commercial fertilizer or manure). Not required if already have or are applying for a Fertilizer Business License (Section II a).
- c) **Fertilizer Applicator License:** Required of any person who applies or supervises the application of any agricultural fertilizer material on behalf of a Licensed Fertilizer Business listed in Section II (a). Must have passed the category 14 fertilizer applicator certification exam. Use a separate form for each additional certified fertilizer applicator.

PLEASE NOTE: If you have a current Indiana commercial pesticide license, you do NOT need to submit this application to add category 14 (fertilizer). Your credential will be automatically updated and mailed to you.
